1) **Preprints:** Upon acceptance of the article for publication, each author warrants that he/she will promptly remove any prior versions of this work (normally a preprint) that may have been posted to an electronic server.

2) **Sole Submission of Original Manuscript:** Each author represents and warrants that the manuscript is the authors' original work (except for any material from previously copyrighted works obtained by permission or assignment and credited as such); that none of the information has been published previously or is under consideration by another publication; that upon publication, the manuscript shall not infringe any copyright, invade any right of privacy, contain any libelous material, or infringe or violate any other right of any person or entity.

3) **Approval Verification:** Each author represents and warrants that investigations involving human or animal subjects received the appropriate institutional approval and agrees to provide evidence of such approval if requested. In addition, each author agrees to produce the data on which the manuscript is based for examination by the editors or their assignees should they request them.

4) **Authorship Certification:** Each author represents and warrants that he or she has fulfilled the definition of authorship given in the Instructions for Authors, participated in this study sufficiently to ensure its integrity and to take public responsibility for it, and approved the manuscript submitted to *Obstetrics & Gynecology*.

5) **Financial Disclosure:** Each author represents and warrants that he or she has no financial affiliation (eg, employment, direct payments, stock holdings, retainers, consultantships, patent-licensing arrangements, or honoraria) or involvement within the last 3 years with any commercial organization with potential financial interest in the subject or materials discussed in the manuscript, except as disclosed in an attachment to this document. Any other potential conflict of interest also is disclosed.

6) **Author(s) Posting of Articles to an Institutional Repository:** *Obstetrics & Gynecology* will permit the author(s) to deposit for display a "postprint" (the final manuscript after peer-review and acceptance for publication but prior to the publisher's copyediting, design, formatting, and other services) 12 months after publication of the final article on his/her personal Web site, university's institutional repository, or employer's intranet, subject to the following:

- You may only deposit the postprint.
- You may not update the postprint text or replace it with a proof or with the final published version.
- You may not include the postprint or any other version of the article in any commercial site or in any repository owned or operated by any third party. For authors of articles based on research funded by the National Institutes of Health (NIH), Wellcome Trust, the Howard Hughes Medical Institute (HHMI), or other funding agency, see Paragraph 7 for the services that Lippincott Williams & Wilkins (LWW) will provide on your behalf to comply with "Public Access Policy" guidelines.
- You may not display the postprint until 12 months after publication of the final article.
- You must attach the following notice to the postprint: "This is a non-final version of an article published in final form in (provide complete journal citation)."
- You shall provide a link in the postprint to the *Obstetrics & Gynecology* Web site.

7) **Compliance With NIH and Other Research Funding Agency Accessibility Requirements:** A number of research funding agencies now require or request authors to submit the postprint (the article after peer review and acceptance but not the final published article) to a repository that is accessible online by all without charge. Within medical research, three funding agencies in particular have announced such policies:

- NIH requires authors to deposit post-prints based on NIH-funded research in its repository PubMed Central (PMC) within 12 months after publication of the final article in the journal.
- HHMI requires as a condition of research grants, deposit in PMC, but in its case within 6 months after publication of the final article.
- The Wellcome Trust requires, as a condition of research grants, deposit in UK PubMed Central within 6 months after publication of the final article.



As a service to our authors, LWW will identify to the National Library of Medicine (NLM) articles that require deposit. This Author Agreement provides the mechanism for identifying such articles. LWW will transmit the postprint of an article based on research funded in whole or in part by one or more of these three agencies to PMC.

Upon NIH request, it remains the legal responsibility of the author(s) to confirm with NIH the provenance of their manuscript for purposes of deposit.

- Author(s) will not deposit their articles themselves.
- Author(s) will not alter the postprint already transmitted to NIH.
- Author(s) will not authorize the display of the postprint prior to:
 - 12 months following publication of the final article, in the case of NIH,
 - 6 months following publication of the final article, in the case of Wellcome Trust and HHMI

8) Journal Research: Manuscripts under consideration are sometimes enrolled in research projects. When this is done, the identity of individual manuscripts and their authors is kept confidential. By submitting to this journal, authors are assumed to give consent for their papers to be used in such research.
